

## Common HR Infotypes

Infotype (IT) #	Infotype Name	Infotype Description
0000	Actions	Most ISRs create an action. (i.e., hires, salary change, reassignments, LOAs, & terminations. The effective date of the action, reason code, position#, personnel area, employee group and employee subgroup are stored on this infotype.
0001	Organizational Assignment	Payr error cost center, Bus area, Fund, EE Group, EE Subgroup, Payr area (i.e, B1, W1, S1), PersAdmin code, PayrAdmin code, Position#, Job key (= to job code on position), Exempt indicator, and Org Unit.
0002	Personal Data	Title, Name, Gender, Date of Birth, Nationality, Second Title (Highest Degree), Suffix, SS# (hidden for security purposes)
0006	Addresses	Work physical location, work mailing, and permanent address
0007	Planned Working Time	Work schedule rule and weekly working hours can be found on this infotype.
0009	Bank Details	Banking information for main bank and other banks (i.e., account #, routing #, name of banking institution)
0014	Recurring Payments/Deductions	Bonus supplements paid in a defined timeframe over several pay periods, parking deductions, credit union deductions, etc.
0015	Additional Payments	Bonus supplements, tuition payments, and any other payments received in a one time disbursement
0019	Monitoring of Tasks	90-day Quota, probationary review, anniversary, return from LOA, & end of temp status, visa expiration dates are all stored on this infotype
0021	Family Member/Dependents	Emergency Contact
0024	Skills	Qualification (Licensure and Certifications types), effective and expiration dates, license/cert #, region

0041	Date Specifications	Original hire, begin accrual, savings eligibility, bargaining unit entry, experience base, and adjusted service dates
0048	Residence Status/Visa and I-94	Visa Information
0077	Additional Personal Data	Ethnicity, Race Category, Veteran Status, Disability Dates
0094	Residence Status	Citizenship or Visa Status
0105	Communications	Travel Reimbursement and Department Code (JHU Only)
0207	Residence Tax	Displays county tax area as it relates to the employees state of residence (permanent address)
0208	Work Tax	Displays work tax area (state) in which the employee work
0209	Unemployment Tax	Displays the same state as the work tax area and the worksite location
0210	Withholdings	Federal and State status, exemptions, withholding adjustments, W-5 filing status, overrides
2010	Remuneration Information	Overtime and bonus supplements
9027	Base Pay & Labor Distribution	PS type, PS area, PS group and level, capacity utility level (FTE % for JHHS), work hours/period, annual salary, hourly rate, semi salary, pace codes, general distribution and percentage(s), labor distribution and amount(s), period review (portion charged to default cost center)
